ROLL CALL AND ESTABLISHMENT OF QUORUM

Ms. Rebecca Downing, Chair, called the committee meeting to order at 10:42 a.m. Roll was called and a quorum was established.

ENF 1 – Approval of the November 4, 2010 Enforcement Committee Meeting Minutes

M/S/C (Bettinger/Olinger) to approve the Enforcement Committee meeting minutes of November 4, 2010. The motion passed unanimously.

ENF 2 – Investigator Activity Reporting (IAR) Computer System Implementation Update
Kim Trefry, Enforcement Chief reported that the IAR system has been implemented. Training was conducted in November 2010. The system went live on December 2, 2010. We have begun running end-of-the-month reports and gathering preliminary data on case activity. Rebecca Downing asked when the Board might be able to see some useful data. Ms. Trefry stated that it will be about 6 months before we will have enough data to indicate any trends.

ENF 3 – Enforcement Statistics

Kim Trefry stated that the reports from the Complaint and Compliance Unit, provided by Lori Reis, regarding cases received, cases closed and average number of days to close a complaint all showed significant improvement. Ms. Trefry reported that the case closures for the Investigative Unit for Fiscal Year 2010-2011 are 423 so far showing an 11% increase from the previous fiscal year.

ENF 4 – Report on New Contract for Probation Monitoring Drug Testing (Information Only)
Kim Trefry reported that the Dental Board entered into a new contract with Phamatech, a biological fluid testing provider. There a 55 licensee's who are subject to drug testing as probationers. These

are exclusive of any requirements of those in the Diversion program. Dr. Bettinger asked what the plan is for probationers who plan to be unavailable due to vacations out of the country etc. Ms. Trefry reported that probationers must provide 72 hours notice and must seek out a testing facility where they will be staying. In addition, Phamatech can work with the probation monitors to alter the testing schedule if deemed necessary.

ENF 5 – Diversion Statistics

Kim Trefry reported that the Diversion Statistics were put together by Lori Reis. Dr. Bettinger noted that the number of participants in the Diversion Program has dropped from 100 to 42 since he became a Board member. Mr. DeCuir stated that speculation has it that there are fewer self referrals due to fear of consequences.

ENF 6 – Report on Dental Consultant Calibration Course for Complaint and Compliance Unit Kim Trefry reported that they have met with the 2 lead consultants on the complaints side and have developed and planned a training day for all Dental consultants on Thursday, April 14, 2011 in Sacramento. They will be working with the Attorney General's office on this training.

ENF 7 - Update on Enforcement Process Improvements

Ms. Downing reported that she and Dr. Casagrande met with staff to discuss what proactive steps could be taken to continue to improve the Enforcement program. Ms. Trefry stated that at the January meeting, they agreed to look at a sampling of many different cases and outcomes to see if they could define some common elements. Ms. Trefry reported that they are planning 6-7 training dates for the Subject Matter Experts, Due to the current shortage of Expert Reviewers, they are planning on reaching out to specialty dentists to get assistance with the Expert Reviews, Dr. Le asked how often training is given. Mr. Salute, from the Attorney General's office stated that the last time the training was done was 2007. Initially, all experts must go through training before they even see a case. This would be in addition to that initial training. Dr. Casagrande stated that this endeavor takes a lot of time, resources and effort but is well worth it for the viability and defensibility of the reports received. Ms. Trefry stated that one other area that was discussed was Cite and Fine. Currently citations remain posted on the website indefinitely. Other Boards have language that limits the amount of time a citation remains on the website. Ms. Trefry stated that this would require legislation so the committee discussed asking the Board to seek an author for this legislation. Ms. Trefry stated that the necessity for this change is that almost all citations result in requests for informal hearings because no one wants the citation posted indefinitely. Mr. DeCuir stated that most of these issues will come up in Sunset Review and his hope is that that will be the opportunity to enhance the enforcement arsenal by making some of these changes. Ms. Downing requested that we agendize the Cite and Fine issue at the next meeting if not addressed through Sunset Review. Ms. Downing commended Kim Trefry on a job well done especially considering the fact that she has only been on the job for 6 months and she's been treated like she's a 20 year veteran. Kudos to Kim.



Following is an update on the ongoing use of the Investigator Activity Reporting (IAR) system for Enforcement Program staff:

Investigator Activity Reporting (IAR) System

Current Status The IAR has now been in operation for 5 months. Enforcement staff have logged time worked in various investigative categories and stages. An early review of the information shows that our non-sworn Investigative Analysis Unit spends approximately 75% of its time on Negligence/Incompetence cases. Of those, a little less than half (38%) move forward for administrative action.


In contrast, the investigative work performed by our two sworn enforcement offices is divided primarily between Unlicensed Activity, Negligence/Incompetence, and Substance Abuse issues. Almost half (44%) are referred for administrative action, and 11% are referred for criminal prosecution. The information is also used to provide accurate cost recovery information to the Board.

The charts attached provide a visual overview of where our combined enforcement efforts have been focused since implementation.

System Upgrades After evaluating the initial reports, we identified the néed to capture time spent performing probation monitoring tasks. We are currently working with the Medical Board to start using this feature.

Investigator Activity Reporting System Hours Worked by Case Type



Cases Received: The total number of complaint files received during the previous 12 months was 3510, averaging 293 per month.

Cases Closed: The total number of complaint files closed during the same time period was 3025, averaging 252 per month.

The average number of days a complaint took to close within the last 12 months was 120 days.

Attached please find Enforcement statistics for the previous 9 - 12 month period. Below is a summary of some of the program's trends:

Case Closures The total number of investigation cases closed, filed with the Attorney General or filed with the District/City Attorney for FY 2010/11 (July 2010 through March 2011) are 671. The Investigation Unit is completing an average of just over 67 investigations per month. This is a 34% increase from the previous fiscal year.

Current Open cases = 1078

Average caseload per fulltime Investigator/Analyst = 40 investigations

Average probation caseload per fulltime Investigator = 9

Average probation caseload for Inspectors = 44

Cases pending assignment = 281

Factors affecting these rates include current vacancies, a hiring freeze and one furlough day per month.

Average Days to Close a Case The average number of days an investigation took to complete within the last 9 months was 473 days. This is an 11% decrease from the previous fiscal year average (533 days).

The number of cases in the oldest category (3 years and older) has decreased 73%, from 38 in November to 10 at the end of March.



SUBJECT	Agenda Item ENF 4: Discussion and Possible Action Regarding Time Limitations for Posting Cite and Fine Actions on the Board's Website

In preparation for the Joint Sunset Review Committee, enforcement staff developed draft regulatory language as a potential remedy to the indefinite length of time that a Citation and Fine is currently posted on the Board's website.

Background

A licensee may be issued an administrative citation for failure to comply with a request to produce medical records (pursuant to B&P Code section 1684.1(a)(1)) or in response to conditions which adversely affect the health, safety and welfare of the dental consumer. Administrative citations can be issued by non-sworn staff and Inspectors.

Upon issuance of a citation, the licensee is given a specific number of days to comply with the order (15 days for records, longer for inspection related corrections). The licensee also has the right to due process and may request an informal hearing to discuss the merits of the citation.

Although the goal of the administrative citation is compliance and/or abatement, unless a citation is withdrawn following an informal hearing, there is currently no provision to remove the posting from the Board's website once compliance is received or the matter has been satisfactorily abated. The absence of this procedural language has resulted in an increasing number of informal hearings, and an increased workload – the opposite effect intended for an intermediate enforcement tool.

Public Disclosure Time Limitations

Staff has researched disclosure language in use by the Medical Board of California, Board of Registered Nursing and several other Boards to develop the following proposed language which modifies website postings from indefinite to 3 or 5 years maximum:

Draft Language:

- (a) Every citation that is issued pursuant to this article shall be disclosed to an inquiring member of the public, unless purged in accordance with the provisions of this section.
- (b) Every citation, once it has been resolved by payment of the administrative fine and/or compliance with the order of abatement, shall be purged three (3) or five (5) years from the date of resolution, except for citations referenced in subsection (c).
- (c) No citation shall be purged if issued relating to public health and safety, and no citation shall be purged for any citation issued against an unlicensed individual.
- (d) A citation that has been withdrawn or dismissed shall be purged from the board's file as soon as administratively feasible, but no sooner than one year from the date of issuance.

Status

Currently, the Board's enforcement program is limited to two methods to address violations of the Dental Practice Act; issuance of a citation and administrative filings with the Office of the Attorney General. This additional language along with recommended changes to statutory language to implement a Letter of Admonishment and Notice of Correction has been provided to the Senate Business and Professions Committee as an additional provision to SB540.

These additions will provide the Board's enforcement program with supplemental tools to address less egregious violations more efficiently.





The Dental Consultant Calibration Course was eld on Thursday, April 14, 2011, at the Dental Board of California (Board's) Sacramen location.

Present were: Board members Luis Dominicis, DS and Thomas Olinger, DDS, 15 Dental Consultants, Gregory Salute, Deputy Attorney General, Denise Johnson, Assistant Executive Officer, Kim Trefry, Chief of Enforcement, Nancy Butler, Supervising Investigator I, Sacramento office, Teri Lane, Supervising Investigator I, Orange office, Investigative Analysis and Complaint Unit staff.

The meeting kicked off with full introductions from all present. After introductions, a power point presentation on the role of the Complaint and Compliance Unit was given. Immediately following the presentation, a continental breakfast was generously provided by the Complaint Unit staff. After the break, Gregory Salute gave a presentation on "What the AG's office is really looking for"? This presentation was very well received and provided a useful insight on what kind of cases actually end up at the Attorney General's office. Also included in the discussion was Richard Liebig DDS who serves as the Board's civil service consultant. Dr. Liebig presented five (5) case scenarios and invited feedback from the 14 other consultants as to how they would handle each case.

In addition to Dr. Liebig's scenarios, Michael Paull, DDS and Patrick Schenk, DDS each presented scenarios for open discussion and debate. Drs. Paull and Schenk are the senior consultants who have provided consulting services to the Board for many years.

A round table discussion ended a very successful and informative calibration. It is my opinion that it will ensure all of the consultants are working parallel and providing similar consultant reports for the Board.

A survey was recently sent out requesting feedback on whether or not the calibration met their expectations, was the proper time allotted, were the handout materials useful, was the information presented in a clear and understandable manner, and if the meeting should be repeated annually, or biannually. Through information received from the survey, it has been determined that future calibrations will again be a one day full session held biannually. In addition, representatives from the AG's Office and case scenarios will again be included in the agenda.

SUBJECT	Agenda Item ENF 7: Update on Enforcement Process Improvements

In response to a February 2010 enforcement assessment, the Enforcement Program has been making a number of improvements; some of which are identified here:

Training Staff are now meeting Peace Officer Standards and Training (POST) standards in the following areas: Tactical Communications training and Arrest and Control Techniques. Firearms Instructors are in the process of applying to have a Tactical Firearms certified to meet POST standards as well.

CURES Access Sworn staff have been granted access to the Department of Justice's Controlled Substance Utilization Review and Evaluation System (C.U.R.E.S.). This database allows immediate access to prescribing records for investigative purposes. Online access provided to our sworn personnel also saves the Board approximately \$40,000 annually from our previous contract services.

Staffing Increased staffing has a direct impact on our ability to collect records, evidence and conduct investigations. The augmentation of positions from the Consumer Protection Enforcement Initiative has already helped the Board address a backlog of cases. However, hiring sworn staff has continued to be a challenge within the hiring freeze.

Both the Southern office (Orange) and Northern office (Sacramento) currently have two sworn investigator vacancies. We have submitted a freeze exemption for these four positions and are awaiting approval. We may still interview and hire applicants from within the Department, but cannot consider any eligible candidates from current hiring lists.

In the non-sworn Investigative Analysis Unit, two staff have moved into the newly created Special Investigator classification, and we have made job offers to two Associate Government Program Analysts to fill behind them. This new unit will now be fully staffed and is carrying almost 50% of the open caseload.

Management Reports The Executive Officer, Assistant Executive Officer and Enforcement managers are all receiving monthly status reports on our enforcement efforts. Caseload, Closure rates and Case Aging reports help identify our ongoing progress to reduce case age and meet the Department's case closure goals of 12 – 18 months.

Policy and Procedure Manuals A new Investigations policy manual has been completed and is pending legal review. Updates for the Probation, Inspections, and Discipline Coordination manuals are anticipated to be completed in the next 6 -12 months.
