Dr. Stephen Casagrande, Chair called the committee meeting to order at 8:11 a.m. Roll was called and a quorum established.

EX 1: Approval of the November 4, 2010 Examination Committee Meeting Minutes

Karen Fischer, Administrative Analyst stated that there were a couple of changes that needed to be made before the vote. On page 3, EX-6, strike the last line beginning with "Dr. Bettinger...." On page 4, middle of the paragraph, strike the line that says "there was lengthy discussion involving the fact" replace with "there was one applicant in the packet for consideration who had never been a Board Examiner". Dr. Morrow stated that there had been a motion in EX-4 to have an agenda item regarding Specialty Licensure on this agenda but he doesn't see it. Dr. Bettinger stated that it was jest an oversight and will be put on the agenda for the next meeting in May. M/S/C (Bettinger/Morrow) to approve the November 4, 2010 Examination Committee Meeting Minutes as corrected. The motion passed unanimously.

EX 2: Registered Dental Assistant Examination Statistics

Donna Kantner, Licensing and Examination Unit Manager, reported that the RDA examination statistics were presented for the committee's review and comment. Dr. Casagrande asked if the cost to test only 10 candidates, as was the case for the RDAEF exam in August, is justifiable. He asks that a cost breakdown be presented at the next meeting. Dr. Dominicis stated that he was encouraged to see that

according to the last two reports on the new exam, the pass rate on the written portion of the exam had continued to improve.

EX 3: Calendar of Upcoming Dental & Dental Assistant Examinations

Dr. Casagrande stated that with the signing of AB 1524, Portfolio, there is no longer a Board exam. Dr. Whitcher asked if every candidate who formerly qualified to take the State Board, qualifies to take the WREB? Richard DeCuir stated yes. Judith Forsythe stated that for Dental Assisting there is an issue with securing a site for the RDA clinical exam in Southern California but staff is working hard to remedy this. There was discussion about the need and difficulties in finding a location to hold the RDA exam in Southern California. Dr. Le asked if the RDA and RDAEF exams could be held at the same time. Dr. Casagrande asked if we need a stand alone exam for RDA's or maybe we should be considering an exit exam from the schools that the board has accredited. Dr. Casagrande would like to see this as an item on the next agenda.

EX 4: Western Regional Examination Board (WREB) Statistics and Update

Dr. Dominicis thanked Dr. Bettinger for once again appointing him to be the representative to WREB from California. Dr. Dominicis reported that the WREB Board of Directors met in January 2011 and among the items discussed was the fact that this is the first year that the WREB Dental exam will be given electronically. The system was thoroughly tested last year and last week the examiners were trained on the electronic scoring system. This will expedite scoring so that candidates should receive their scores in 5-7 working days. WREB reported that there were 2600 Dental examination candidates last year with only 6 examination appeals filed and 1800 Hygiene examination candidates with 5 examination appeals filed. New officers were elected and the next WREB Board of Directors meeting will be in Park City, Utah on July 21, 2011.





Dental

There are no California Clinical Dental Board examinations scheduled. To date, all applicants have applied for the WREB clinical examination, as the WREB results are accepted in 33 states.

Effective May 2, 2011, the Written Law and Ethics examination for dentists has been offered via computer based testing at Psychological Services Inc. (PSI). Test centers are available in the following locations: Anaheim, Atascadero, Bakersfield, Carson, El Monte, Fresno, Hayward, Redding, Riverside, Sacramento, San Diego, Santa Rosa and Santa Clara. There are also 10 sites outside of California, available to the dental applicants only, Cranberry Township, PA, Boston, MA, Atlanta, GA, Charlotte, NC, Southfield, MI, Des Moines, IA, Albuquerque, NM, Houston, TX, Las Vegas, NV and Portland, OR. PSI is administering each exam with randomized test questions.

Candidates are required to apply for their initial examination with the Board. Once approved, an electronic file is sent to PSI a handbook is mailed to the candidates. The handbook contains instruction on how to schedule an exam, testing locations and the outline of the examination. Candidates are required to pay a fee of \$23.00 to PSI for the examination. Upon completion of the examination, candidates are immediately notified of their result. Candidates who do not successfully pass the examination are given a re-examination form and may immediately schedule a new examination with PSI. When a candidate passes the examination, the result letter states that the result is valid for two (2) years. The candidate results will be sent electronically to the Board.

Staff will provide written statistics at future Board Meeting.

An examination site in Southern California was confirmed on March 16. Because the filing period for the April examination had closed, examination staff called all candidates living in Southern California to let them know about the new site and offer them the opportunity to change their examination site without penalty. Approximately 100 candidates were moved to the southern site. A new filing period was also opened for those candidates who had not previously applied for the northern site. There are 329 candidates scheduled for the Pomona location.

Staff will be administering the RDAEF exam on May 21 and October 15 at UCLA and on October 22 and 23 at Sacramento City College.
