Dr. Whitcher, Chair, called the committee meeting to order at 9:45am. Roll was called and a quorum was established.

<u>LCP 1 – Approval of the February 25, 2010 Licensing, Certification, and Permits Committee</u> <u>Meeting Minutes</u>

M/S/C (Forsythe/Dominicis) to approve the May 5, 2010 Licensing, Certification, and Permits Committee meeting minutes as presented. The motion passed unanimously.

LCP 2 - Dental, RDA and RDAEF Licensure & Permit Statistics

Dr. Bruce Whitcher reported that his comparison of the statistics for the last 9 months showed that Dental Licenses have gone up 466, RDA licenses have declined by 351. The delinquency rates for Dental licenses has remained in proportion, even though the number of RDA licenses have gone down, the number of RDA delinquencies has risen. Dr. Whitcher speculated that this probably just reflects the economy and the rate of unemployment. The concern is that the RDA population has declined leaving a shortage of assistants. RDAEF licenses have declined by 17. Dr. Whitcher's review of the Pathway to licensure showed little change. Dr. Whitcher reported that Licensure by Type remained consistent. Dr.Lori Gagliardi, CADAT, asked if there were any statistics for the Orthodontic Assistant Permit or the Dental Assisting Sedation Permits that have been issued. Dr. Whitcher stated that he didn't think there had been any issued yet. Dr. Lori Gagliardi asked if the stats for RDAEF I and RDAEF II could be broken down separately. Dr. Whitcher agreed to add those stats.

LCP 3 - General Anesthesia/Conscious Sedation Evaluation Statistics

Dr. Whitcher reported that the statistics remain consistent with past years. The program is working well with almost 300 evaluations being done in both categories.

<u>LCP 4 – Update Regarding 2011 General Anesthesia Conscious Sedation Evaluator</u> Calibration Courses

Dr. Whitcher reported that two Evaluator Calibration Course dates had been selected for approval; Wednesday March 16, 2011 in Northern Ca. and Wednesday March 23, 2011 in San Diego. There will be a whole new course this year which will count toward CE credits.
