ROLL CALL AND ESTABLISHMENT OF QUORUM

Dr. Whitcher, Chair, called the committee meeting to order at 8:34 a.m. Roll was called and a guorum was established.

LCP 1: Approval of the November 4, 2010 Licensing, Certification, and Permits Committee Meeting Minutes

M/S/C (Dominicis/Forsythe) to approve the November 4, 2010 Licensing, Certification, and Permits Committee meeting minutes. The motion passed unanimously.

LCP 2: Dental, Registered Dental Assistant and Registered Dental Assistant in Extended Functions Licensure & Permit Statistics

Dr. Whitcher gave a review of the Licensure statistics. He reported that during the past 1² month period February 2010 – February 2011, 535 Dental Licenses have been added, 664 licenses awarded by the WREB exam. During that same period there was a decrease in Registered Dental Assistant licenses however, there was a relatively large increase in renewals. There was very little change in the Registered Dental Assistant in Extended Functions category.

LCP 3: General Anesthesia/Conscious Sedation Permit Evaluation Statistics

Dr. Whitcher reported that General Anesthesia (GA) permits increased by 5, there was a decrease of 1 Conscious Sedation (CS) Permit and in the Oral Conscious Sedation Category, 98 were added. During the 12 month period of February 2010 to February 2011, 203 GA evaluations were conducted

with 2 failures, 61 CS evaluations with 7 failures. This has been the trend over the past few years. Dr. Whitcher stated that we have been keeping up with the General Anesthesia evaluations but staff reported that we are a little behind on the Conscious Sedation evaluations due to a shortage of evaluators. We are actively recruiting to fill these positions.

LCP 4: Update Regarding 2011 General Anesthesia Evaluator Calibration Courses

Dr. Whitcher stated that as he mentioned before, we will be holding 2 Evaluator Calibration Courses in March, one in the Bay area and one in Southern California. There has been a good response so we are hopeful that we will be able to fill the positions.

The Dental Board of California held two GA/CS/MGA Evaluator Calibration Training Courses this year. The courses were held March 16, 2011, in South San Francisco and March 23, 2011, in San Diego.

March 16, 2011, South San Francisco

The Northern California course was held at the Hyatt Regency Hotel in South San Francisco and was presented by Dr. Bruce Whitcher, Dr. Suzanne McCormick, Dr. Richard Moorhouse, and Dr. Guy Acheson. The three (3) hour course was attended by seventy (70) current GA/CS/MGA permit holders. In addition, the Board was able to recruit Twelve (12) new evaluators for the inspection program.

March 23, 2011, San Diego

The Southern California course was held at the Handlery Hotel in San Diego and was presented by Dr. Suzanne McCormick, and Dr. David Tracy. The three (3) hour course was attended by sixty nine (69) current GA/CS/MGA permit holders. In addition, the Board was able to recruit seventeen (17) new evaluators for the inspection program.

Dr. Whitcher and Dr. McCormick may wish to further expand on these Calibration courses.

SUBJECT	LCP 5: Update Regarding Fingerprinting Requirements for Licensees

Background:

Regulations were recently approved by the Office of Administrative Law (OAL), California Code of Regulations Sections 1007, 1008 and 1017.2, implementing the process for requiring electronic (Live Scan) fingerprinting of all licensees for whom no record exists at the Department of Justice (DOJ). These regulations have an effective date of July 1, 2011. Affected licensees must submit evidence that they have completed the Live Scan process as a condition of renewal. This requirement includes dentists, registered dental assistants, and registered dental assistants in extended functions.

Update:

DOJ has provided the Dental Board a list of all licensees for whom no record of fingerprinting exists. Information, including Frequently Asked Questions, has been placed on the Board's website and staff is in the process of notifying by mail those licensees who must be fingerprinted whose licenses expire in July, 2011.

The Board must absorb this workload within its current level of staffing, therefore we plan to notify the 18,137 affected dentists, oral and maxillofacial surgeons and special permit holders and the 17,899 affected RDA and RDAEF licensees on a "rolling" schedule month-by-month according to their expiration dates so that staff is not overly burdened by sending out all of the notices at once. This spreads out over a two-year timeframe the notification and subsequent staff work to receive and process the proof of fingerprinting and the clearances as they arrive. We expect to mail out and receive documentation of compliance from between 1,000 and 1,500 licensees each month over the next 24 months until this project is completed.
