# **Agenda Item 3: Staff Report**

Ms. Leslie Kihara reported that there is one (1) application to review and that there were currently 32 EFCS permit holders, of which 28 were actively practicing in California.

Ms. Kihara also reiterated that the upcoming meeting dates were set for Wednesday, April 18, 2018; Wednesday, July 11, 2018; and Wednesday, October 17, 2018.

Dr. Louis Gallia brought up the topic of recruitment to the Committee to fill behind Dr. Brian Wong's vacant position. Mrs. Sarah Wallace, Assistant Executive Officer, confirmed that while the Board was currently recruiting for the vacancy that it had not yet been filled. Dr. Gallia also requested to discuss whether it would be appropriate for him to fill the role of a physician or surgeon with a specialty in otolaryngology and recruit for a dual degree Oral and Maxillofacial Surgeon. Mrs. Wallace advised the Committee to add the topic as a future agenda item.

Dr. Gramins reported that the Credentialing Committee reviewed one (1) application.

Applicant Dr. R.C.: Dr R.C. applied for a category II permit, limited to botox and fillers. The Committee felt that the applicant's submitted documentation did not fulfill the requirement of operative reports. Dr. Gramins requested for Ms. Kihara to send the applicant a letter to request documentation of his procedures.

Dr. Gallia asked the Committee whether one of the members would be able to prereview applications to ensure that there is a complete application to review at the meetings. Dr. Gramins confirmed that in the past he had reviewed previous applications on many occasions.

The Committee moved to table to application until the applicant can submit at least 10 operative reports.
