**AGENDA ITEM 1 - Approval of October 3, 2012 Meeting Minutes**

## **AGENDA ITEM 2 – Staff Report**

Mrs. Nellie Forgét informed that Staff had nothing to report on the Elective Facial Cosmetic Surgery (EFCS) Permit application revisions or regulatory language.

Mrs. Forgét reported that the Committee's recommendation to issue Dr. Alexander Antipov a permit for Category I and Category II privileges went before the Board meeting on December 3<sup>rd</sup> & 4<sup>th</sup>. The Board granted Dr. Antipov an EFCS Permit for Category I and Category II privileges.

Mrs. Forgét reported to the Committee of *The Report on the Elective Facial Cosmetic Surgery Permit Program as Provided by Business and Professions Code Section 1638.1, January 1, 2013* that was submitted to the Legislature pursuant to Business and Professions Code section 1638.1 (k).

Mrs. Forgét concluded by reporting that there were currently twenty two (22) permit holders.

## **RETURN TO OPEN SESSION - Recommendations to the Dental Board of California Regarding Elective Facial Cosmetic Surgery Permit Applications**

Dr. Gramins reported that the Credentialing Committee reviewed three (3) applications.

Applicant Dr. E.S.: The Committee determined that Dr. E.S.'s application was incomplete and asked that Staff contact the applicant and request hospital privileges, specifically cosmetic privileges, from the Seton Medical Center, the hospital he was granted active status at.

Applicant Dr. J.P.: The Committee determined to recommend to the Board to issue Dr. J.P. a permit limited to the following Category II procedures: facial fillers and facial neurotoxins. M/S (Gramins/Scheer). By roll call vote, the motion was passed unanimously.

Applicant Dr. S.R.: The Committee determined to recommend to the Board to issue Dr. S.R. a permit limited to the following Category I procedures: Genioplasty and chin implants. M/S (Scheer/Gramins). By roll call vote, the motion was passed unanimously.
