## THE HOT SHEET – A SUMMARY OF ADMINISTRATIVE ACTIONS

### May – December 2008

*A summary of administrative matters for the Dental Board of California and Committee on Dental Auxiliaries:*

### DECISIONS AFTER ADMINISTRATIVE HEARING

**CHANG, Hoon Young, DDS 41902**  
Effective 10/17/08

Revocation for findings of gross negligence and incompetence based on inadequate record keeping, insurance fraud, failure to diagnose or treat, and excessive treatment.

**DANG, Hieu, DDS 46775**

Effective: 1/26/09  
Early termination of probation granted.

**DIAZ, Luis, DDS 28677**

Effective 10/24/08  
Early termination of probation granted.

**JENSEN, Suzanne, DDS 41793**

Effective 10/10/08  
Revocation stayed with 3 year probation based on a 2005 misdemeanor conviction of a crime substantially related to the functions, duties and responsibilities of a licensee. Writ filed appealing decision in San Bernardino Superior Court on January 15, 2009.

**JONES, Dusty, RDA 61365**

Effective: 10/17/08  
Revocation based upon a 2005 conviction and failure to comply fully with previous probation Order.

**KERBY, Joe Kent, DDS 35131**

Effective: 1/26/09  
Revocation stayed with 2 year probation based upon 2004 misdemeanor conviction of a crime substantially related to the qualifications, functions and duties of a dentist.

**MANCHEVA, Zanka, DDS 42359**

Effective: 10/10/08  
Revocation stayed with 3 year probation based on gross negligence, repeated acts of negligence, and unprofessional conduct (records) in treating 1 patient.

**MORALES, Veronica, RDA 73115**

Effective: 1/26/09  
Revocation stayed with 3 year probation based upon a 2004 misdemeanor conviction substantially related to the functions, duties and responsibilities of a licensee, and making a false statement on her application.

**NGUYEN, Randy, DDS 43828**

Effective: 10/17/08  
Early termination of probation denied

**RUCKER, Raymond, DDS 27831**

Effective 10/17/08  
Previously revoked license will be reinstated with 5 years probation once specified conditions are met.

**SAN PABLO-POWLEY, Dana Shae**

Aka San-Pablo, Dana  
Aka Powley, Dana Shae  
RDA Applicant  
Effective 1/26/09  
License application denied.

### STIPULATED SETTLEMENTS

**ALLEN, John Edward, DDS 28270**

Effective: 7/3/08  
Voluntary surrender. Stipulated that if proven at hearing, allegations constitute cause for discipline. Board alleged unprofessional conduct and repeated acts of negligence in treating one patient.

**BODHAINE, Gregrey, DDS 37634**

Effective: 10/17/08  
Revocation stayed with 5 year probation and 45 days of actual suspension. Stipulated that if proven at hearing, allegations constitute cause for discipline. Board alleged 2006 felony conviction of a crime substantially related to the functions, duties and responsibilities of a licensee. Also alleged unprofessional conduct for obtaining a fee by fraud or misrepresentation.

**DELGADO, Jorge, RDA 72561**

Effective: 10/17/08  
Probationary license issued with revocation stayed and 5 year probation. Two misdemeanor convictions for crimes substantially related to the qualifications, duties, and functions of an RDA.

**DESAI, Trupti, DDS 47876**

Effective: 10/17/08  
Public Reprimand with terms and conditions. Stipulated that if proven at hearing, allegations in the Board's Second Amended Accusation constitute cause for discipline. Board alleged gross negligence or repeated acts of negligence and unprofessional conduct (record keeping) in treating one patient.

**HAMER, Larry DDS 43604**

Effective: 7/3/08  
Revocation stayed with 3 year probation. Stipulated that if proven at hearing, allegations constitute cause for discipline. Board alleged unprofessional conduct for theft of property.

**HARIRI, Payam, DDS 52569**

Effective: 10/17/08  
Voluntary surrender of license in a stipulation agreeing that cause exists for discipline. Board alleged discipline taken by the State of Maryland is based on grounds which would be the basis for discipline in California.

**HIPPENSTEEL, Joseph, DDS 16179**

Effective: 10/17/08  
Revocation stayed with 3 year probation. Stipulated to the truth of the Board's allegations of a 2005 conviction of a criminal offense substantially related to the qualifications of a dentist (utilizing an unlicensed person to perform duties that require an RDH license).

**HIPPENSTEEL, Julie, RDH 21915**

Effective: 10/17/08  
Revocation stayed with 3 year probation. Stipulated to the truth of the Board's allegation of a 2005 conviction of a crime and for conduct that would have warranted the denial of the license.

**LOOP, Jason, DDS 57912**

Effective 10/17/08  
Probationary license issued with revocation stayed and 3 year probation. Stipulated to the truth of a 1999 misdemeanor conviction of a crime substantially related to the functions, duties and responsibilities of a licensee.

**MATIAN, Kamal, DDS 30585**

Effective: 10/17/08

1 year extension of current probation. Stipulated with admissions to the Board's allegation that he failed to comply fully with the terms of a previous Board probation Order.

**MC CARTNEY, Patricia, RDH 10949**

Effective: 1/26/09

Stipulated to revocation of her license.

**NGUYEN, Anisha, DDS 55386**

Effective 1/26/09

Revocation stayed with 3 years probation. Stipulated to the truth of a 2007 misdemeanor conviction of a crime substantially related to the functions, duties and responsibilities of a licensee.

**NGUYEN, Duc Sy, DDS 45507**

Effective: 10/06/08

Revocation stayed with 3 year probation. Stipulated that if proven at hearing, allegations constitute cause for discipline. Board alleged gross negligence, incompetence, and repeated negligence in treating 3 patients.

**PERRY, William Litt, DDS 57748**

Effective: 10/17/08

Probationary license issued with revocation stayed and 5 year probation. Stipulation with admission that Board- alleged discipline taken by the State of Texas constitutes cause for denying his application for license.

**POOLE, Brandi, RDA 55763**

**aka Brandi Michelle Bryant  
aka Brandi Michelle Singletary  
aka Heather Renfro**

Effective: 1/26/09

Stipulated to the surrender of her license based upon admitting the truth of the Board's allegations of a 3 separate convictions in 2002. Convictions were for crimes substantially related to the functions, duties and responsibilities of a licensee.

**RASHTI, Mahnaz, DDS 42412**

Effective: 11/23/08

Revocation stayed with 3 year probation. Stipulated that if a hearing were held, the Board could establish a factual basis for the allegations. Board alleged gross negligence or incompetence, and excessive and negligent treatment of three patients.

**ROSTAMI, Behnam, DDS 49653**

Effective: 10/17/08

Revocation stayed with probation for 5 years with 30 days actual suspension. Stipulated that if proven at hearing, allegations in the Board's First Amended Accusation constitute cause for discipline. Board alleged gross negligence, incompetence, repeated negligence, excessive treatment, insurance fraud.

**SIZELOVE, Gloria, RDA 57964**

Effective: 7/3/08

Revocation stayed with 3 year probation. Stipulated to the truth of a 2007 conviction of a crime substantially related to the functions, duties and responsibilities of a licensee.

**CASTRO, Maria, RDA 49522**

Effective: 1/26/09

Revocation based upon Board's allegation that she failed to comply fully with the terms of a previous Board probation Order.

**MANCINAS, Nohemy, RDA 53059**

Effective: 10/17/08

Default revocation when licensee failed to respond to the Board's allegation of a 2004 misdemeanor conviction of a crime substantially related to the qualifications, functions or duties of an RDA.

**MANTLE, Linda, RDA 55871**

Effective: 1/26/09

Default revocation based upon Board alleged failure to comply with previous probation order.

**WYMAN, Arlene, RDA 46124**

Effective: 10/17/08

Default revocation based on Board alleged failure to comply with previous probation order.

**These administrative actions were taken From May 1 - December 31, 2008. The decisions become operative on the effective date, except in situations where the licensee obtains a court ordered stay. This may occur after the publication of the administrative action in the Hot Sheet. Stay orders do not occur in stipulated decisions, which are negotiated settlements waiving court appeals.**
