<u>LCP 1 - Approval of the February 24, 2011 Licensing, Certification, and Permits Committee Meeting Minutes</u>

M/S/C (McCormick/Afriat) to approve the February 24, 2011 Licensing, Certification, and Permits Committee Meeting Minutes. The motion passed unanimously.

LCP 2 - Dental and Dental Assisting Program Licensure and Permit Statistics

Dr. Whitcher reviewed the statistics provided. Dr. McCormick asked about the cause of the delinquencies. Dr. Whitcher said that he did not have the information at hand but would look into it. Regarding permit renewals, Dr. Dominicis would like to see a box that can be checked and sent back indicating that they do not want to renew. This would avoid having these permits go into delinquent status.

LCP 3 - General Anesthesia/Conscious Sedation Permit Evaluation Statistics

Dr. Whitcher reviewed the statistics provided.

LCP 4 - Update Regarding 2011 General Anesthesia Evaluator Calibration Courses

Dr. Whitcher reported that as a result of the two calibration courses held in March we were able to recruit 12 new evaluators in San Francisco and 17 in San Diego.

LCP 5 - Update Regarding Fingerprinting Requirements for Licensees

Dr. Whitcher reported that our fingerprinting regulations were recently approved by the Office of Administrative Law (OAL). These regulations will become effective July 1, 2011. Mr. DeCuir stated that we will try to have a preliminary report for the Board at the August Board meeting.

M/S/C (Afriat/McCormick) to refer this Agenda Item to the Full Board with no recommendation. The motion passed unanimously.



General Anesthesia Permits - Since the Board's last meeting, the numbers above reflect an increase of thirteen Active permits, the same number Delinquent and two Cancelled.

Conscious Sedation Permits – Since the Board's last meeting, the numbers above show an increase of 9 permits, 4 fewer delinquent permits, and no change to the number Cancelled.

Oral Conscious Sedation Permits – Since the Board's last meeting, the numbers above show an increase of 20 Adult Only Permits and a decrease of 29 Adult and Minors Permits. 22 permits have become Delinquent since the last report and 3 permits have been Cancelled.


Cancelled Status – In November 2009, the definition of Cancelled status on the Board's website was updated as follows:

- A licensee may choose to cancel a permit. Cancellation of a permit by the licensee means that the
 permit is no longer required or needed. A Board issued permit may be cancelled or delinquent while
 the dental license is current and valid for practice.
- A permit is cancelled if it is delinquent for five (5) years or the Board has cause. This Permit is cancelled and no longer valid.
- You may contact the Board to see why the permit was cancelled

Business and Professions Code Section 1718 allows renewal of a license within 5 years of expiration. Section 1718.3 prohibits a license from being "renewed, restored reinstated or reissued" upon cancellation.

SUBJECT	LCP 4: Update Regarding Fingerprinting Requirements for Licensees

Background:

New regulations, California Code of Regulations Sections 1007, 1008 and 1017.2, were approved in March of this year by the Office of Administrative Law (OAL), to implement the requirement and process for electronic (Live Scan) fingerprinting of all licensees for whom no record exists at the Department of Justice (DOJ). Effective July 1, 2011, licensees for whom no such record exists must complete the Live Scan process as a condition of renewal, beginning with licenses that expire in July of 2011. This requirement includes dentists, registered dental assistants, and registered dental assistants in extended functions.

Update:

DOJ has provided the Dental Board a list of all licensees for whom no record of fingerprinting exists. Information, including Frequently Asked Questions, has been placed on the Board's website and staff has mailed notices to licensees who must be fingerprinted as a condition of their July, August and September 2011 renewals. Renewal notices have a section licensees must complete to certify that they have met the requirements for Live Scan fingerprinting.

At this time, notices have been sent to licensees whose licenses expire in July, August and September 2011, a total of 2,204 dentists, 2 Oral and Maxillofacial Permit holder, 1 Special Permit holder, 2,190 RDAs, and 59 RDAEFs.

The Board must absorb this workload within its current level of staffing. We plan to continue to notify the 18,137 affected dentists, oral and maxillofacial surgeons and special permit holders and the 17,899 affected RDA and RDAEF licensees on a "rolling" monthly schedule according to their expiration dates so that staff is not overly burdened by sending out all of the notices and receiving all conviction information at once. Staff are tracking calls and emails related to this project and a statistical report will be provided at the next Board meeting.

We expect to continue to mail out between 1,000 and 1,500 notices to licensees each month over the next 24 months until this project is completed.
