# AGENDA ITEM 1 - Approval of April 17, 2013 Meeting Minutes

## **AGENDA ITEM 2 – Staff Report**

Dr. Gramins reported there was no update on the Elective Facial Cosmetic Surgery (EFCS) Permit application revisions or regulatory language.

## <u>AGENDA ITEM 3 – Future Meeting Dates</u>

Mrs. Karen Fischer informed the Committee that they needed to agree on dates for the 2014 future meetings. Mrs. Jackson confirmed the Committee's agreement on the future meeting dates of January 22, 2014, April 16, 2014, July 9, 2014, and October 1, 2014. Dr. Gallia added that next year's AAOMS meeting was scheduled for September so it would not conflict with the October meeting.
