# **President's Message**

The Dental Board of California: Who we are, how we got here, and what we do.

Government ... is complicated.

The Dental Board of California's reason to exist is found in the Business and Professions Code (BPC), beginning with section 1600, known as the California Dental Practice Act.

The estimated population in California in 2025 is about 39,529,000. That's a lot of people to whom the Board is ultimately answerable. Through the government, there are multiple levels and tiers of authority to execute those words and responsibilities, as outlined by the DPA. Language in government is very specific. The state Legislature delegates authority to the Board to govern the dental profession through licensing, regulation, and discipline.

On accepting an appointment to the Board, Board members take an oath. We affirm our overarching guide and anthem—in **any** decision by the Board—is: "**The Protection of the Public . . .**"

In California, there are approximately 32,389 actively licensed dentists. The U.S. Bureau of Labor Statistics reports there are 55,360 dental assistants employed in California. That's a lot of professionals under the Board's oversight. That's a lot of responsibility to those 39 million people. There are numerous definitions that guide this healing art for the public.

While the DPA guides the Board's navigation, the marketplace continues to evolve. The Board learns and adapts while continuously executing ongoing, multifaceted, multifunctional duties.

In 2025, the Board's activities include the following:

- Examining general anesthesia in dentistry.
- · Updating infection control standards.
- · Searching for an Executive Officer.
- Expanding onboarding and outreach.
- Strategic planning 2026—2029.

# Message From the Chair of the Dental Assisting Council



De'Andra Epps-Robbins, DAC Chair, RDA

My name is De'Andra Epps Robbins, and I currently serve as the Chair of the Dental Assisting Council (DAC). I am a licensed registered dental assistant with over 28 years of experience working in the San Diego area. I have been a member of DAC since March 2022

At the most recent DAC meetings in May and August, DAC engaged in a robust discussion on several

key topics. These included updates on registered dental assistant (RDA) and registered dental assistant in extended functions (RDAEF) educational programs and courses, application approvals and reevaluations, pending infection

control regulations, and proposed legislation (Assembly Bill 873 Alanis, 2025), related to dental assistants, and radiation safety, infection control, and interim therapeutic restoration and radiographic decision-making courses.

DAC holds quarterly public meetings that are open to everyone—no special invitation is required. These meetings aim to encourage public involvement and welcome comments from a wide range of stakeholders, including dental assistants, dental hygienists, dentists, students, and the public. We also value input from representatives of professional organizations and other interested groups.

The Board reminds licensees that Senate Bill (SB) 501 (Glazer, Chapter 929, Statutes of 2018) significantly amended the requirements for obtaining Board-issued general anesthesia and sedation permits. The Board implemented these statutory changes through the **SB 501 Anesthesia and Sedation Rulemaking**. Significant changes to the general anesthesia and sedation permits include:

# General anesthesia (GA) and medical general anesthesia (MGA):

- A pediatric endorsement of a GA or MGA permit is required to administer or order the administration of deep sedation or GA to patients under 7 years of age.
- Moderate Sedation (MS):
- Conscious sedation (CS) permits are no longer issued or renewed. MS permits have replaced CS permits.
- A Pediatric endorsement of an MS permit is required to administer or order the administration of MS to patients under 13 years of age. There are two options for the pediatric endorsement for MS permits: for patients ages 7-12 and for patients under the age of 7.

#### **Oral Conscious Sedation for Adult Patients (OCS-A):**

 SB 501 did not make substantive changes to OCS-A certificate requirements. OCS-A certificates are required to administer oral conscious sedation on an outpatient basis to adult patients unless the dentist possesses a GA or MS permit. SB 1453 (Ashby, Chapter 483, Statutes of 2024) amended the OCS-A statutes to conform and update those statutes for consistency with the GA and MS permit statutes.

#### **Pediatric Minimal Sedation (PMS):**

- Oral conscious sedation for minors (OCS-M) certificates are no longer issued or renewed. Dentists who desire to administer pediatric minimal sedation to patients under 13 years of age must obtain a GA permit, an MS permit with pediatric endorsement, or the new PMS permit.
- It is important to note that, according to <a href="BPC section">BPC section</a>
  <a href="BPC section">1647.32</a>, subdivision (d)</a>, a PMS permitholder "shall be limited to administering a single drug whose primary purpose is sedative via the oral route, either singly or in divided doses, not to exceed the manufacturer's maximum recommended dose, plus a mix of nitrous oxide and oxygen and adjunctive agents such that the drugs either singly or in combination are unlikely to produce a state of unintended moderate sedation. This section shall not be construed to restrict the administration of adjunctive medication intended to relieve pain, affect the onset or duration of the primary sedative agent, or to reduce the side effects of sedation, including nausea or emesis."

### **Fraud Alert**

The Board has learned scam artists posing as Board staff are continuing to call California licensees as part of ongoing attempted fraud schemes. The callers identify themselves as Board staff members or investigators, notify the licensee that they are under investigation for various violations by the Board and sometimes other entities, including local police, the Drug Enforcement Agency (DEA), and/or the Federal Bureau of Investigation (FBI), and demand money. The callers may be "spoofing" the Board's phone numbers to make the calls appear to be coming from the Board.



#### PLEASE CONSIDER THE FOLLOWING:

- If you receive a call from someone claiming to be Board staff, or other suspicious call, contact the Board directly at (877) 729-7789 or (916) 263-2300, or via email at dentalboard@dca.ca.gov, to inquire if an official investigation is being conducted.
- If the caller states they are from the DEA, report the scam using the DEA's Extortion Scam online reporting form.
- If the phone number of the caller appears to be the Board phone number, it is recommended that you submit an online complaint with the Federal Communications Commission (FCC) using the FCC's Consumer Complaint form or contact the Board so it can provide the information to the FCC.
- Do not disclose any personal information, such as social security numbers, dates of birth, or credit/debit card numbers.

## Did You Know?—Notes From the Enforcement Unit

The Board's Enforcement Unit would like to pass on some important information to licensed dentists and individuals working in a dental office:

#### **Closing Dental Practice and Ending Patient Care**

There are times when a dental practice must close its doors and discontinue patient care. Reasons for these closures range from illness of the dentist owner, sale of the practice, or business conditions forcing the closure. The dentist of record needs to plan and coordinate the practice closure to ensure continuity of patient care and to protect the license of the dentist.

Dentists are required to provide written notice of office closure to patients of record. The written notice must be given in advance to provide patients an ample opportunity to secure the services of another dentist. Most commonly, this notice provides the date of office closure (usually 30 or more days after issuance of the notice of office closure), process for patients to pick up dental records (if desired), and a referral or emergency dentist for patients to contact after the office closure. Most providers give a final date for dental records to be picked up.

Failure to provide notice to patients could result in patient abandonment allegations.



# Unlicensed Practice Provisions upon Incapacity or Death of Dentist

If a dentist becomes incapacitated or passes away, the dental practice can continue with licensed personnel providing treatment, and ownership of the practice can be transferred to the dentist's estate. BPC section 1625.3 states:

- (a) Notwithstanding any other provision of law, upon the incapacity or death of a dentist, if the requirements of Section 1625.4 are met, any of the following persons may employ licensees and dental assistants and charge for the professional services they render for a period not to exceed 12 months from the date of the dentist's death or incapacity without being deemed to be practicing dentistry within the meaning of Section 1625:
  - (1) The legal guardian, conservator, or authorized representative of an incapacitated dentist.
  - (2) The executor or administrator of the estate of a dentist who is deceased.
  - (3) The named trustee or successor trustee of a trust or subtrust that owns assets consisting only of the incapacitated or deceased dentist's dental practice and that was established solely for the purpose of disposition of the dental practice upon the dentist's incapacity or death.
- (b) The persons described in subdivision (a) shall not interfere with, control, or otherwise direct the professional judgment of a licensee or dental assistant lawfully acting within licensee's or dental assistant's scope of practice as defined in this chapter.

This 12-month exemption allows the estate or family to coordinate the sale or transfer of the dental practice while the practice continues to operate and provide care by licensees.





# Dental Board of California Sunset Bill SB 1453 Implementation Update

Many of the Board's Sunset Bill, SB 1453 (Ashby, Chapter 483, Statutes of 2024) changes became effective January 1, 2025.

## New Application Requirements for Registered Dental Assistants (RDA)

SB 1453 made changes to the requirements for registered dental assistant applicants. ## Changes to Requirement for Unlicensed Dental Assistants to Complete Infection Control Course

SB 1453 now requires unlicensed dental assistants to complete a Board–approved eight–hour course in infection control (IC) prior to performing any basic supportive dental procedures involving potential exposure to blood, saliva, or other potentially infectious materials. The employer of the unlicensed dental assistant is responsible for ensuring that they complete the IC course. (BPC, § 1750, subd. (c))

NOTE: Dental assistants who have evidence of completion of a Board–approved IC course do not need to retake the course.

# Implementation of Infection Control Course Requirements Delayed Until Further Notice

SB 1453 created a new electronic Infection Control (IC) course, but implementation of Board approval providers

of this new course has been delayed. Accordingly, Board–approved IC course providers are required to continue providing instruction pursuant to California Code of Regulations (CCR), title 16, section 1070.6. A list of Board–approved IC course providers is available on the <a href="#">Approved</a>

# Implementation of New Radiation Safety Course Requirements Delayed Until Further Notice

For Radiation Safety Course Providers and RDA Program Providers, there will be a delay in implementing the new radiation safety course requirements described in SB 1453 and codified as **BPC section 1754.5**.

Until further notice, Board–approved radiation safety course providers are required to continue providing instruction pursuant to CCR, title 16, sections 1014 and 1014.1. Board–approved RDA program providers are required to continue doing so as well, pursuant to CCR, title 16, section 1070.2, subsection (d)(9)(A).

# Did You Know?—Notes from the License and Examination Unit

#### The License and Examination Unit would like to pass on some important information that may impact licensees:

Renewing your license and permits is crucial to maintaining current licensure in California. The Board has an online-only renewal process to serve licensees better. A paper renewal is no longer mailed, and instead, you will receive a reminder postcard approximately 90 days before your license or permit expires.

Even if you do not receive the renewal reminder postcard, it is still your responsibility to renew your license or permit. If you do not renew within five years of the expiration date, your license or permit will automatically cancel.

To renew, visit <a href="www.breEZe.ca.gov">www.breEZe.ca.gov</a>. If you do not have a BreEZe account, click "New User" to create one. Once you are logged in, start the renewal process by clicking the blue "Select" button under "License Activities." If you have more than one license or permit, you can add them to your BreEZe account by clicking the "Update Profile" tab.

#### **Important Updates to Fictitious Name Permits**

Did you know that dentists who use a fictitious name for the dental practice are required to apply for and maintain a Fictitious Name Permit issued by the Board? Effective January

- 1, 2025, SB 1453 introduced significant changes to the statutes governing fictitious name permits for dental practices. Key updates include:
- **1. Dentist Name Requirement:** Dentists are no longer required to include their names in the fictitious names of their practices.
- 2. **Permit Validity:** Permits will now be valid for two years from the date of issuance, with renewals required biennially. This is a change from the previous system, where permits expired concurrently with the dentist's license.
- **3. Name Change Process:** If a dentist departs from a practice and their name remains part of the fictitious name, other dentists within the practice are required to apply to have that name removed from the fictitious name.
- **4. Location Restriction:** Permits are location-specific. If your dental practice moves, you will need to apply for a new permit and cancel the existing permit.

# Diversion Program Update



Dental professionals are not immune to substance use disorders. In fact, they can be at greater risk due to the availability of drugs in the workplace and work-related stress that accompanies operating a practice. An alcohol or drug problem, if left untreated, may impair a dental professional's abilities and pose a risk to the health, life, and safety of their patients. To address this problem using a therapeutic and rehabilitative approach, the Board developed the Diversion Program in compliance with BPC section 1695.5.

The Diversion Program is a confidential program for the treatment and rehabilitation of dental professionals who become impaired due to the use of dangerous drugs or alcohol (that is, chemical dependency). It provides individuals with the ability to understand their illness and receive ongoing support in their journey to sobriety.

#### **Diversion Program services include:**

- Confidential consultation with professionals in the field of substance use disorders.
- Intervention services.
- Assessment of treatment needs and referral to appropriate resources.
- Assistance in the development of a recovery plan.
- Monitoring of compliance.
- Encouragement and peer support.

If someone develops a substance use disorder, they are often too close to the problem to be objective. They may not recognize or address it, which can make the issue more serious and difficult to resolve. Alternatively, they may attempt to cope with the problem on their own, which can lead to increased stress and exacerbate the situation.

The first step in dealing with an alcohol or drug problem is for the individual to admit they have a problem and ask for help. A tremendous weight on one professional can become lighter when shared with someone trained to counsel and help others with a substance use disorder.

The Diversion Program accepts referrals on a voluntary basis, and licensees can also be referred to the program by the Board or through the formal disciplinary process. Any licensed dental professional in California who is experiencing an alcohol or drug dependency problem can seek assistance and apply for admission into the program by calling (800) 522-9198. This toll-free number is open 24 hours a day.

All requests for information and assistance are strictly confidential. Records maintained by the Diversion Program are confidential and not subject to discovery or subpoena. However, in compliance with BPC section 1695.5, subdivision (f), program records may be provided to the Board's enforcement unit or used in a disciplinary proceeding if the licensee fails to comply with the program's terms or is determined to be a threat to the public or their own health and safety.

Once a dental professional contacts the program, arrangements will be made for a confidential evaluation by a licensed professional. After the evaluation, the individual will meet with the Board's Diversion Evaluation Committee (DEC) for formal acceptance into the program. The DEC members, who the Board appoints, are fellow dental professionals and experts in the field of substance use disorders and are dedicated to helping dental professionals overcome substance abuse.



The Board's regulations are in the California Code of Regulations (CCR), title 16, division 10, commencing with section 1000. More information is available on the **Board's Laws and Regulations website**.

#### **Dental Assisting Exams**

This rulemaking updates the dental assisting examination regulations in accordance with current examination requirements of the Board for dental assistant licensees, establish a criterion-referenced passing score for dental assisting exams for RDAs, RDAEFs, OAs and DSAs, remove references to examinations that have been discontinued and/or superseded by changes in laws and regulations, links the examinations to the examination outlines prepared by the Department of Consumer Affairs, Office of Professional Examination Services (OPES), and repeals regulations related to dental hygienist examinations that have been superseded by regulations established by the Board. These changes are intended to better protect California consumers by ensuring examinations meet minimum standards for qualifying applicants for licensure, and by ensuring consistency in the Board's examination actions.

Sections affected: Amend 16 CCR sections 1080, 1080.3, 1081 and 1081.2; Adopt new sections 1081.3 and 1081.4; and Repeal sections 1080.1, 1080.2,1081.1, 1082, 1082.1, 1082.3, and 1083.

The regulations became effective on January 1, 2025, except for CCR, title 16, section 1081, which took effect upon filing with the Secretary of State's Office.

#### **Uniform Standards for Substance-Abusing Licensees**

The Board's existing regulation for Uniform Standards are used in addressing substance-abusing licensees. This rulemaking updates the Board's existing Uniform Standards, which are incorporated by reference, to align with the updated Uniform Standard. This rulemaking adopts new subsections that outline and expand on the existing parameters of the Substance Abuse Coordination Committee's Uniform Standards in regulation for clarity. This rulemaking also adds new CCR, title 16, section 1018.02, which outlines the criteria for issuing a cease practice order, requirements for providing notice to the subject licensee, and the process for appeal.

Sections affected: Amend 16 CCR section 1018.01; Adopt section 1018.02.

The regulations became effective on January 1, 2025.

# Disciplinary Guidelines and Exceptions for Uniform Standards Related to Substance-Abusing Licensees

This rulemaking updates the Board's Disciplinary and Denial Guidelines for licensees and applicants. The Board adopted the guidelines for use by administrative law judges, attorneys, licensees, and any individual involved in settlement of accusations or statements of issues proceedings. The rulemaking updates the regulation and the guidelines, incorporated by reference, to remove outdated terms and conditions of probation and conform to changes in statute and the probationary environment since the last update.

Section affected: Amend 16 CCR section 1018.

The regulations became effective on January 1, 2025.
